Oregon Health Authority (OHA) Update: Joell Archibald

- See IA (Innovator Update) packet on IHNtogether.org.
- Highlights:
 - o COVID-19 (coronavirus) related deaths changed to around 75 per hour.
 - o Vaccines may start shipping in next week and in Oregon by the 3rd week in December.
- Discussion:
 - The two-week look back for county risk level will most likely be reported on Thursday with a Friday effective date.
 - o Traditional Health Workers (THWs) have direct contact with people but there is no specific call out within the plan.

 - Alignment of timing of regional Community Health Improvement Plans (CHIP), hospital community benefit plans, county plans, and the SHIP relies on all plans, there are federal rules around the hospital community benefit plans.

 - o PartnerSHIP (SHIP advisory workgroup/committee) is releasing a call for applications soon with a January 8, 2021 due date.
