

<u>Pilot Updates: Andrea Myhre and Stacey Bartholomew</u>

- Skills and Connections to Support Housing
 - Very challenging to do this work doing the pandemic. The pilot was really focused on providing inperson skills, trainings, and supports to members.
 - Biggest takeaway: One on one work with people is so important.
 - This work will continue but will pick up after COVID-19 is "over".
 - Corvallis Housing First was approved for Project Turnkey and are using the funds to purchase the Budget Inn in Corvallis to support housing services.
- Hub City Village
 - Successes include:
 - Partnership building.
 - Potential donations of up to one third of project budget identified. In early 2021 additional resources were found to reach feasibility threshold.
 - There are a few land options that seem promising.
 - Political backing from Mayor and State Representative.
 - Seeking unhoused residents for advisory group.
 - Grant application for land acquisition.

- Challenges include:

Strategic Planning: Request for Proposal

- See the March 2021 Strategic Plan pages 8-9.
 - Process elements of the RFP:
 - Like the small versus big projects.
 - Small organizations that have not been successful in applying should be encouraged to return.
 - Health equity standards how to make it less challenging?
 - Sometimes the best ideas do not even make it to a proposal.
 - Ideas include making it very easy to pitch ideas then provide more engagement in filtering the ideas.
 - Discussion around barriers:
 - Developmental projects with large support from the Committee.
 - Concerns over penalizing pilots/programs for being new or less technologically sophisticated.
 - Support for a less strenuous request for proposal process.

Request for Proposal (RFP) Summary of Discussions through March 2021

Process:

- Continue past RFP process for budgets over \$50,000:
 - Letter of interest
 - o Application
 - o Presentation
 - Discussion and recommendations
 - RPC (Regional Planning Council) approval
- Add smaller/easier to apply process for budgets under \$50,000
 - Ensure this process is equitable
 - Suggestion to allow this process for organizations with an annual operating budget under a certain amount
- Provide a mentorship channel for past pilot champions to mentor through the process
- Allow for two year pilots with the understanding that funding is provided only in the first year
- Provide technical to assistance to approved pilots on data collection and evaluation as well as contracting and payment mechanisms
 - IHN-CCO is creating an internal workgroup

Application:

- Ensure the documents are translated into Spanish
 - All other languages, large format, braille, and more are available upon request
- Utilize universal design standards for improved accessibility
 - Need volunteers to carry this out
- Add details on the environmental scan to reduce duplication of efforts and increase partnerships and collaboration

Other:

- Sustainability as a yes/no criteria piece rather than being rated on the 1-10 scale
- Use number of partners brought to the table as a measure of success

Priority Areas:

- Trauma.
- Increasing and improving access to behavioral health care in light of COVID-19.
- Housing.
- Language access.
- Developing a bilingual and bicultural workforce.
- Pay equity through building and sustaining the workforce.
- Improving access to behavioral health services in non-traditional ways.
