





Pilot Progress Report Updates

- Wellness in Neighborhood Stores
 - A collaborative project with Oregon State University (OSU) and Linn County Public Health. Previously halted by COVID-19, the project has been reinvigorated and interviews will begin this summer, collecting insights and prospective of store owners and shoppers regarding food access. Foresee potential challenges with community engagement and store buy in. Local Champions have not been identified as of now, possible recruitment opportunities as outreach and interviews begin. DST member suggestion for specific store in Albany.
 - Transformation will follow up on connections post DST.
- Namaste Rx
 - Currently contracted with 3 yoga studios and 2 more to come. Seeing a large amount of community buy in. Moving forward with working on getting customers and a website created. Website will include provider portal that will work for the providers and members. Currently only open to adults for the first year with plans to expand capacity for children.
 - Transformation team will follow up to facilitate exchanging possible information regarding website builds for other potential pilots.

Transformation Update

 Community Doula Program was highlighted and IHN-CCO's Alicia Bublitz presented to the Centers for Medicare and Medicaid Services (CMS) for low-risk cesarean learning collaborative.

Legislative Update

- 1115 Waiver Renewal State of Oregon and Centers for Medicare and Medicaid Services (CMS) does this renewal every 5 years, this allows the Medicaid program to happen. Oregon Health Authority (OHA) is actively negotiating right now, and the Federal Government will approve this fall and changes will be in effect July 2023. We could see some substantial changes.
- Redeterminations During the COVID-19 state of emergency, the States were told to not disenroll members from state Medicaid programs. 1.4 million members will now have to renew, starting sometime next year. Oregon Health Authority is actively working on how to make this successful.
- Bridge Plan This will be for the individuals who no longer qualify with the 139-200% poverty level, anticipate around 200k people. Current concerns would be facilitating how to keep members insured and engaged with care coordination. Current major gaps concerns are incarcerated members transitioning back to the community, kids aging out of foster care.
- Behavioral Health System Currently underfunded and new funding will be coming in, around \$0.5 billion will be put towards the Behavioral Health System. Oregon Health Authority rates will be changing July 1, 2022. CCO's will not be getting additional funds to support this increase until January 2023. DST community member question of concerns for decrease in services for the next 6 months, we do not anticipate any drop-in services to happen at the CCO level.
- Healthier Oregon Includes a group of individuals that do not qualify for Medicaid because of immigration states. Oregon is putting money into the Healthier Oregon program to include adults, as well as children that are already covered. Enrollment with IHN-CCO will begin July 1, 2022 there is currently still a lot of work happening to get this message to eligible peoples.
- REALD/SOGI Race, Ethnicity, Language or Disability (REALD) and Sexual Orientation or Gender Identity (SOGI). This is a state law that requires the collection of this information at least once a year through CCO/Dental/Insurance Providers. This is to help with health equity and match with communities that we are serving.

Pilot Progress Report Updates

- Peer Enhanced Emergency Response
 - Creating support for peers experiencing crisis in the community. Currently has a hotline and staff to deescalate crises. Crisis line is open 24/7 and has a high demand. Several peer action plans were created to strengthen community relations surrounding community crisis, and law enforcement officers. Current need is securing a vehicle to

transport peers when in crisis. As well as looking for additional ways to fund the program after the end of the year.

- Pathfinder Behavioral Health Transformation
 - Presented by current Pathfinder member. Helping to transform access to non-traditional behavioral health services for adults experiencing mental illness, homelessness, or socio-economic inequities compounded by the COVID-19 pandemic. Currently serving 138 individuals. The current increase in utilization proposes concerns around capacity. Experiencing challenges in staffing recruitment, using current network for recruitment and connecting with soon or recent graduates.
- Women Veterans Cohort
 - First in person event will be held August 2022. A lot of recent challenges prevented this initiative from moving forward at the anticipated pace, but lots of DST support was received. DST support to help with sharing of the survey as well as connect with community partner contributions. Lots of asks to include contact email and/or survey link.
