COVID-19 Current Status

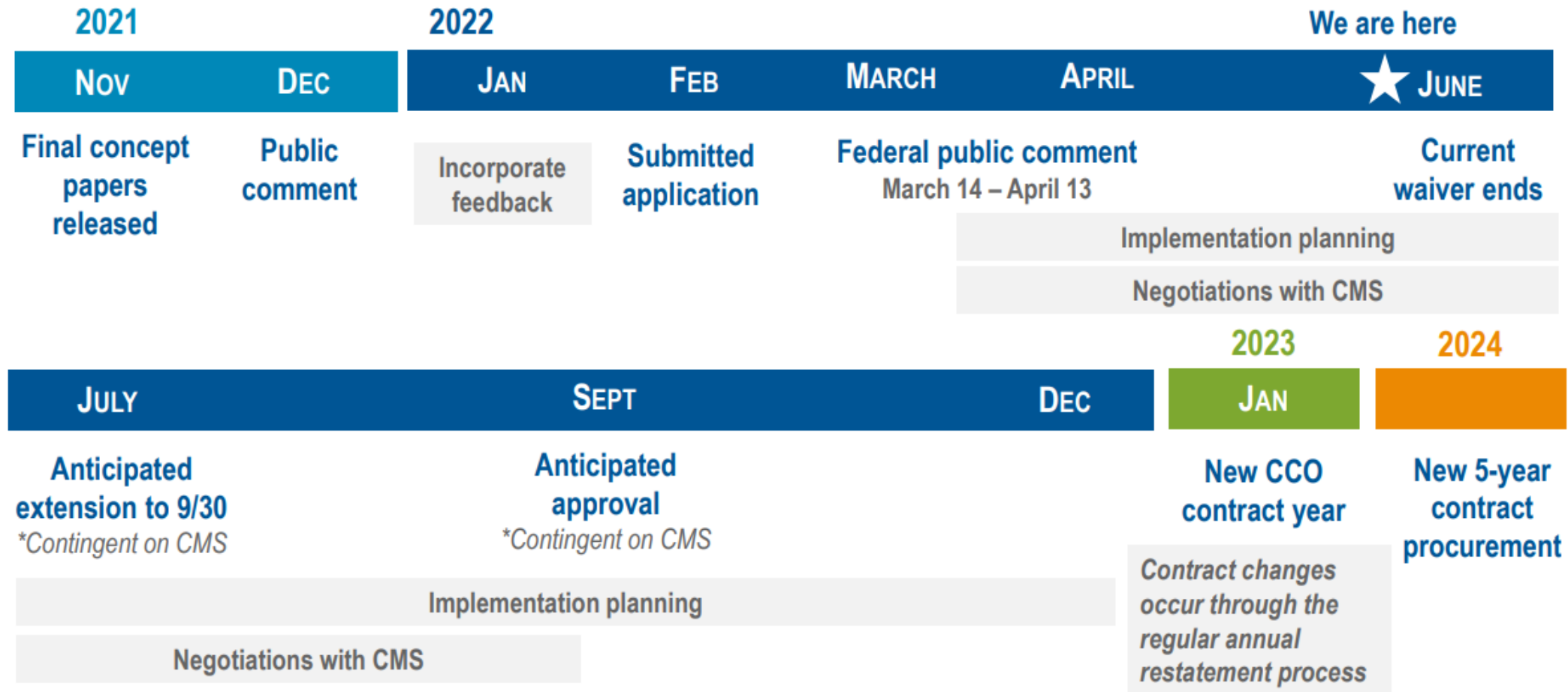

Forecast shows rise in cases, hospitalizations as BA.4 and BA.5 Omicron subvariants spread

- OHSU released a new COVID-19 forecast last Friday, showing a rise in COVID-19 cases and related hospitalizations and deaths in the next few weeks.
- This is due to the spread of Omicron variants BA.4 and BA.5, which are the most transmissible of the COVID-19 variants so far.
- Forecast show an expected peak by mid-July, infection rates may be similar to the Omicron wave last winter.
- On Friday, there were 423 people in Oregon are hospitalized with COVID-19. These numbers may rise to 479 by mid-July. Deaths also expected to rise.

Update: CMS Discussion Topics

- Designated State Health Programs (DSHP)
- Managed care rates
- Community Investment Collaboratives
- Social determinants of health (SDOH) benefits packages
- Justice-involved and institutional care requests
- Youth with Special Health Care Needs (YSHCN)
- Continuous enrollment and coverage expansion
- Peer-delivered services and community health workers
- Early Periodic Screening, Diagnostic and Treatment (EPSDT) and Prioritized List
- Tribal requests

Redeterminations

- First major goal of OHA during this prep period: work with members to ensure contact information is up to date.
- Process is currently underway to share member contact information between CCOs and OHA.
- Once the redetermination process starts, members will have 90 days to respond to any renewals. First notice after 30 days and second notice after 60 days.
- Current plan for outreach will be to tailor outreach for each audience: members determined ineligible v. members who have not responded.

Other OHA Updates

- CCO 2023 initial contract draft has been completed. OHA is now soliciting feedback from CCOs.
- The OHA Community Partner and Outreach Team has funded community partners across the state for the Healthier Oregon Program outreach. Partners to be announced this week.
- CAC and Regional Health Equity Coalition meeting to discuss the *Community Investment Collaborative* concept included in the new Medicaid waiver proposal, to be rescheduled in the following weeks.
