



Small RFP Pilot Discussions

- Transitioning into a Home
 - Allows for assistance in furnishing a home, relationship building as well as delivering fresh produce to allow for families to have meals together. Additionally, pilot educates around how to utilize, store and cook the fresh produce that is delivered.
 - Recommend adding support with hygiene items.
 - There was some concern around sustainability.

Walk N' Roll

- This is something that is already offered, but not free of charge. It is a much-needed thing, if people are receiving these services without a cost to them, then that is a huge factor for IHN-CCO members.
- Concerns around how the pilot plans to be more interactive with the participants with technology barriers.
 - There was mention that the program would be able to give technology to the member so that they would be able to see the full body of the teacher. The pilot will be buying an upgraded technology system so that it offers better engagement and interaction.
- Very positive feedback that there was a wide variety of partners. Also, positive feedback that this would be in Lincoln County.

The Health Collective

- Priority areas are translation materials, integration of language, building videos in English and Spanish, as well as focused on the pillars of lifestyle medicine.
- Creating culturally appropriate videos from the beginning not simply translated after English creation.
- o There were asks of what the relation is to Samaritan Health.

- Samaritan would be a fiscal sponsor. The person that would be working for Samaritan would be on their own as well as in collaboration with community partners to develop these materials and videos.
- Positive feedback that this would use different medias.
- Concerns as far as transformative, couldn't see much collaboration outside of the project to help drive the product outside of Lebanon and felt more like a department program.

Health Navigation Station

- Consensus that this is increasing the accessibility for folks, in a peer support sort of way, to help navigate, success and in the process become their own health navigators as they learn.
- Appreciation of the project and that it is bringing this directly to the people, instead of them having to come find the project.
- Also like that there are already services/resources that are already in place. Possible that they could figure out how to duplicate this for others as it would be great to have as a replicable process.
- A current concern is that it is hard for folds to go find people and/or programs to assist.
 It is empowering for the person to have this readily available; it takes it off their "to do" list, immediately.
- There were comments and a consensus that the Pilot should have asked for more funding. Could have put more money into the training of the volunteers that will be doing the work. For such a small investment, it is possible to really leverage into other faithbased communities.
- Recommendations that we give them more funding.

Amplifying Voices

- There was a lot of positive feedback that art has been a huge tool in reaching youth (and attendance driver) and giving them the outlet to have a conversation about health and need.
- Positive feedback that there was a long list of partners that the Pilot was already hoping to work with. Will be interesting to see how these partnerships come to fruition.
- It was pointed out that there is not a program for the LGBTQIA+ in Samaritan already and that this program will bridge that gap with Samaritan and the community in this area.
- A bulk of the sustaining program will be from Samaritan. More of the consumable items are what will need help with sustainability.
- A big positive is that this will add focus to reaching a population/demographic that is
 typically hard to reach, involving young adults and behavioral health. Traditionally there
 is such vulnerability and programs like this is how we begin to change that.
