# CAC Responsibility: IHN-CCO Community Health Improvement Plan (CHIP)

- The CAC is responsible for adopting a Community Health Improvement Plan to be used by IHN-CCO as a strategic population health plan
- The CHIP sets the priorities for funding improvement projects in Benton, Lincoln, & Linn counties
  - Delivery System Transformation Pilot Projects
  - Social Determinants of Health funding (SHARE Initiative)

## 2019 - 2024 CHIP Priorities

- Access to care
- Behavioral health
- Child & youth health
- Healthy living (such as nutrition and physical fitness)
- Maternal health
- Social Determinants of Health & Equity
  - Housing access
  - Transportation access
  - Healthy food access
  - Health equity

# Oregon Health Authority (OHA) CHIP Requirements Within its Service Area

- CCOs must publish a new CHIP at least every 5 years
- Develop one <u>shared</u> Regional Health Assessment (RHA) and CHIP by Partnership for Community Health (Partnership)
  - ► IHN-CCO
  - ► CAC
  - Tribe(s)
  - County Public Health Departments
  - 5 Hospitals (3-year schedule)
  - (United Way is also a partner)

## Proposed 2023 CAC & Local Committees CHIP Process

- 1. CAC to agree on CHIP priority recommendations to send to the *Partnership* May 2023
- 2. CAC request that Local Committees do this work and bring back for CAC approval at May 2023 CAC meeting
- 3. Local committees meeting process, with guidance of outside consultant
  - a) January Outline process, go over data from RHA & past CHIP
  - b) <u>February</u> Brainstorm priorities
    - (IHN-CCO will bring local ideas back to *Partnership* and combine them with the community priorities identified by the Regional Health Assessment, IHN will also look at them through the lens of the CCO Contract to make sure we are following requirements)
  - C) <u>March</u> Consultant will return to local meetings with what was heard from three committees and finalize local recommendations to CAC
- 4. <u>May CAC meeting</u> Vote on proposed CHIP priorities outlined by the *Partnership for Community Health*

# Partnership for Community Health process, spring-fall 2023

- June 2023 The Partnership for Community Health, including several CAC representatives, will invite community groups, individuals, and populations to participate in workgroups to set CHIP goals and strategies.
- July October 2023 Process still to be determined, will include adoption by the CAC, possibly at Sept or November meeting
- November 2023 publish final 2024 CHIP
